DISCUSSION OF STEPHANIE L. FURNISH'S ENGAGEMENT LETTER

MAYOR ADAMS TOLD COUNCIL THAT STEPHANIE FURNISH'S SERVICES WOULD INCLUDE PREPARATION OF JOURNAL ENTRIES AND THE FINANCIAL STATEMENT, AS WELL AS CONSULTING SERVICES THROUGHOUT THE YEAR. SHE WOULD PROBABLY WORK THREE TO FOUR HOURS PER MONTH IN THE BEGINNING. IT COULD POSSIBLY DROP DOWN TO ONE HOUR PER MONTH. THE FEES FOR BOOKKEEPING AND CONSULTING SERVICES WOULD BE BILLED AT \$50 PER HOUR. SHE ESTIMATED THE FEES FOR THE FINANCIAL STATEMENT PREPARATION SERVICES WOULD RANGE FROM \$3,200 TO \$4,000. RAISOR, ZAPP, & WOODS, PSC SAID THE AUDIT FEE COULD DECREASE \$1,900 TO \$3,000 IF ALL GOES AS PLANNED. THIS WOULD BE A YEAR TO YEAR CONTRACT.

MAYOR ADAMS TOLD COUNCIL THAT MS. FURNISH IS REQUESTING A DESIGNATED COUNCIL MEMBER ALSO SIGN THE ENGAGEMENT LETTER.
